**EXHIBITING AGREEMENT**

This is an agreement between the company described above and referred to here as Exhibitor and Golden Ticket Marketing and Events, referred to here as Event Manager. Exhibitor agrees to prepare an exhibit of its products and/or literature. Exhibit space must be paid in full before the Exhibitor is permitted to install its display. Further, Exhibitor agrees to comply with the conditions, rules, and regulations printed in this agreement.

This contract will be effective upon receipt of this signed form and payment. Payment is due in full upon contracting for exhibit space. If Exhibitor has not occupied the reserved space by the time the exhibition opens, the Event Manager is authorized to occupy that space or cause that space to be occupied as the Event Manager deems is in the best interest of the Exhibition without in any way releasing the Exhibitor from any liability.

Exhibitors can fill the space as they desire. Exhibition materials may not obstruct the view or space of neighboring exhibits. Exhibitor materials may be stored directly beneath the table, but the floor space around the table must be free and clear of obstructions at all times. The exhibitor may secure signage to the front or sides of the table so long as the signage does not reach into any aisle.

The general rule of the exhibit floor is "be a good neighbor." Exhibits that interfere with the use of other exhibits, impede access to other exhibits will not be permitted. Product demonstration is allowed but only if the demonstration does not cause noise that disrupts the business of other exhibitors. All permitted prearranged demonstrations and distribution of promotional material must be confined to the limits of the space issued. Event Manager reserves the right to impose limitations on noise and/or other methods of operations that become objectionable.

All exhibits must be installed during the designated exhibitor installation hours. An exhibit staff member must be in charge of the display during the hours when the exhibit area is open. Each exhibitor agrees to maintain installed display space through all exhibit days and hours. **If an exhibitor dismantles before the show ends, the exhibiting company will not be allowed to exhibit at the following year's event.** In the event the exhibitor fails to comply with any provisions concerning the use of display space, Event Manager reserves the right to take possession of the space and shut down the booth.

**TERMS AND CONDITIONS**

Event Cancellation: Exhibitors must send a letter of cancellation within 30 days of the specified event date for a full refund. Should the exhibitor cancel within the thirty days prior to the event, fifty percent of the total exhibit space cost will be refunded to the exhibitor. If the exhibition facility becomes unfit for occupancy or if the holding of the exhibition would be substantially or materially affected by causes outside the control of the Event Manager then the Event Manager will not be liable for fulfillment of this contract. If the exhibition or any part of it is terminated, then the Event Manager may retain such part of an Exhibitors rental as shall be required to compensate it for expenses incurred up to the time such a contingency shall have occurred, and there shall be no further liability on the part of the Event Manager.

Limits of Liability: Exhibitor agrees to indemnify and hold harmless the Event Manager, sponsors, the exhibition hall and city in which the exhibition is being held, and their officers, agents and employees, against all claims, losses, suits damages, judgments, expenses, costs and charges of any kind resulting from Exhibitors occupancy of the space herein contracted for by reason of personal injuries, death, property damage or any other cause. The Event Manager shall not be responsible for loss or damage to displays or goods belonging to exhibitors. All such items are brought to the show and displayed at the Exhibitor's own risk. Exhibitor agrees that the Event Manager shall not be responsible in the event of any errors or omissions in the show program or promotional materials. Exhibitor shall be held responsible for any and all damages to the exhibit hall caused by the installation, occupancy or dismantling of its exhibit. In such cases, the facility shall designate a contractor for the repair and the Exhibitor shall make restitution for the damage.
